APPLICATION FOR MEMBERSHIP AND ELECTRIC SERVICE

The undersigned (hereinafter called the "Applicant") hereby applies for membership in, and agrees to purchase electric energy from The Satilla Rural Electric Membership Corporation (hereinafter called the "Cooperative") upon the following terms and conditions:

1. Upon approval of this application by the Cooperative, the Applicant will pay to the Cooperative a \$5.00 membership fee, a \$20 account establishment fee (a portion of which is used to obtain a credit report on the Applicant), and a service security deposit to be determined in accordance with the credit history of the Applicant.
2. The Applicant will, when electric energy becomes available, purchase from the Cooperative all electric energy used by the provided service, and will pay there for monthly at Board approved rates determined in accordance with the Policies of the Cooperative.
3. The Applicant will comply with and be bound by the provisions of the Bylaws, Policies and Service Rules and Regulations as may from time to time be adopted by the Cooperative.
4. As an approved member, the Applicant assumes no personal liability or responsibility for any debts or liabilities of the Cooperative. The acceptance of the application by the Cooperative shall continue in force until termination by any failure of the member to abide by the provisions set forth in the Bylaws, Policies or Service Rules and Regulations of the Cooperative, or until cancelled by at least thirty (30) days written notice given by either party to the other.
5. **As a condition of membership, the Applicant, upon being requested by the Cooperative, shall execute and deliver to the Cooperative without charge, easements of right-of-way over, on, and under such land owned or leased by or mortgaged to any member, and in accordance with reasonable terms and conditions, as the Cooperative shall require for the furnishing of electric service to such members or other members for the construction, operation, maintenance, or relocation of the Cooperative's electric facilities.**

By signing the Application for Membership and Electric Service, the Applicant certifies that: 1. All of the information provided by the Applicant is correct to the best of his/her knowledge; 2. The Applicant has been offered a New Member Packet of Materials by the Cooperative detailing the Bylaws and Service Rules of the Cooperative; and 3. The Applicant gives his/her express permission and authorization to check the credit status of the Applicant through the Online Utility Exchange program used by the Cooperative.

CONTINUITY OF SERVICE

The Cooperative will endeavor to furnish continuous service but does not guarantee uninterrupted service and is not liable for any damage which the member may sustain by reason of the failure or partial failure of the power, failure or reversal of phases, or variation in service characteristics whether caused by accident, repairs, storms or incurred by the use of any service wiring, connection, instruments, service or appliances installed by or for the member; nor is the Cooperative liable for damages that may be incurred due to the presence of the Cooperative's property on the member's premises. In the case of three-phase service required by the member, the installation and maintenance of adequate relays with circuit breakers to protect against single- phase conditions and phase reversal are desirable and their installation and maintenance is the responsibility of the member.

TERMS OF MEMBERSHIP

This certificate and the membership evidenced hereby are not transferable except as provided in the Bylaws of the Cooperative, and such membership may be terminated as provided in said Bylaws. Each member shall be entitled to one vote and no more upon each matter submitted to a vote at a meeting of the members and such vote may be cast by the member or his or her spouse. No one else shall be eligible to cast such vote. If a husband and wife hold a joint membership, they shall jointly be entitled to one vote and no more upon each matter submitted to a vote at a meeting of the members of the Cooperative.

This Certificate of Membership supersedes and replaces any certificate heretofore issued to the member and the membership represented hereby is subject to all terms, conditions and limit actions contained in the Charter and Bylaws of the Cooperative and all amendments thereto and in the application of the holder or holders thereof for membership in the Cooperative.
